

CONTEST RULES

Held on the Facebook and Instagram profiles of the Organizer on May 28– June 30 2026
(hereinafter referred to as the "Rules" and the "Contest")

These Rules regulate the conditions of participation in the Contest, the procedure and steps required for its implementation, and outline the rights and obligations of the participants..

1. General provisions

- 1.1. Organizer of the Contest: City Park Center a.s., Bencúrova 10, 040 01 Košice, Slovakia, Company ID: 36213624, registered in the Commercial Register of the Municipal Court in Košice, Section Sa, Insert No. 1214/V (hereinafter referred to as the "Organizer").
- 1.2. By participating in the Contest announced by the Organizer, the participant expresses their agreement with these terms and conditions as well as the Contest rules specified in the Contest announcement, and agrees to comply with them.
- 1.3. The Organizer reserves the right to suspend, shorten, extend, terminate, or unilaterally change the Contest and its prizes at any time, even without providing a reason, effective from the moment of publishing the new rules on the Organizer's respective social media profile.
- 1.4. Winners will be selected by a committee formed for this purpose by City Park Center a.s. The drawing will be performed via random selection from participants who meet the conditions for inclusion, as specified by these Rules.
- 1.4. The Organizer's social media refers in particular to Facebook VILLA SANDY RESORT and Instagram VILLA SANDY Resort, found under the name @villasandyresort (hereinafter referred to as "social media").
- 1.5. Participation in the Contest and any prizes cannot be legally enforced.
- 1.6. Any complaints or objections related to the Contest will be decided by the Organizer. Objections must be sent in writing to the postal address listed in these rules within 3 business days of the end of the Contest. Later objections will not be considered.

2. Location and Duration of the Contest

- 2.1. The contest is being held in the Slovak Republic through the registration of participants, who must fill out the Registration Form with the required information and submit it to the Organizer at any of the café and restaurant locations of VILLA SANDY Resort, Mestský Park 7, 040 01 Košice.
- 2.2. The contest runs from May 28, 2026, and ends on June 30, 2026, at 10:00 p.m.

3. Conditions for participation

- 3.1. Participation in the Contest is permitted only if the Contest terms and conditions defined in these Contest Rules are complied with.
- 3.2. A contestant is entitled to enter the contest only once, via the Registration Form, which must contain all required information as indicated on the form.
- 3.3. The Organizer reserves the right, without providing a reason, to exclude any participant whose behavior exhibits signs of unfair or fraudulent conduct, or whose behavior violates the general rules.
- 3.4. Contest Terms and Conditions for Participation:
 - a) participation in the "Walk Through Košice" event with the theme "VILLA SANDY and City Park," held from May 28 to June 1, 2026, and simultaneously
 - b) spending at the VILLA SANDY resort on any services or goods, and simultaneously
 - c) submitting a fully completed Registration Form to the staff at VILLA SANDY resort facilities upon payment for said expenses.

4. Eligible participants

- 4.1. Only individuals with full legal capacity may participate. Minors may enter only with the consent of a legal guardian.



- 4.2. Employees of the Organizer or related parties (per Sections 116 and 117 of Act No. 40/1964 Civil Code) or collaborating legal/physical entities and their close persons may not participate. If such a person wins, the prize is forfeited to the Organizer.
- 4.4. Persons not meeting the requirements or acting against the rules will be excluded from the Contest..

5. Contest prize

- 5.1. The prizes in the contest consist of 4 separate prizes intended for 4 separate winners:
 - a) First prize: Sunday brunch for 2 people at the SEVEN restaurant (Mestský park 7, Košice) with a total value of 90 EUR (in words: ninety euros), on a date to be agreed upon with the Contest Organizer,
 - b) Second prize/Winner: A half-day breakfast for 2 people at the EMOTI tavern (Mestský park 7, Košice) with a total value of 45 EUR (in words: forty-five euros), on a date to be agreed upon with the Contest Organizer.
 - c) Third Prize/Winner: An outdoor gathering with a drink and cake for 2 people at the POINT kiosk (Mestský park 7, Košice) with a total value of 40 EUR (in words: forty euros), on a date agreed upon with the Contest Organizer,
 - d) Fourth Prize/Winner: A tennis experience for 2 people with a certified coach for 2 hours on the tennis courts at the VILLA SANDY resort (Mestský park 7, Košice) with a total value of 30 EUR (in words: thirty euros), on a date to be agreed upon with the Contest Organizer.
- 5.2. The prize is gross value. It cannot be claimed legally or exchanged for cash..
- 5.3. Competition prizes in excess of € 350 are subject to personal income tax pursuant to Section 8(1) of the Income Tax Act No. 595/2003 Coll. as amended, and the winners are obliged to comply with this Act when taxing the prize. At the same time, such prizes within the meaning of §10b of Act No. 580/2004 on health insurance, as amended, constitute income which enters the assessment base for the calculation of health insurance and which must be settled in the annual health insurance settlement. In the event that the value of the prize exceeds € 350 per prize, the Organizer will inform the Contestants of this fact.

6. Selection of the Contest Winner and Notification of the Prize

- 6.1. 6.1. After the Contest Period has ended, the Contest Winners will be selected by the Contest Organizer through a random drawing from among all Contest participants who have validly entered the Contest. The announcement of the Contest Winners will be published on the Organizer's relevant social media platforms and/or via a phone call or private message to the Winner at the phone number provided in the Registration Form.
- 6.2. 6.2. If the Organizer is unable to contact any of the Winners within 7 days of the announcement of the Contest Winners, or if the Winner fails to provide the Organizer with the necessary cooperation and information for the delivery of the prize, or if the Winner refuses the prize, that Winner forfeits their claim to the prize and the Organizer will draw a substitute Winner.
- 6.3. 6.3. If the winner is a minor, they are required to provide the Organizer with written consent from their legal guardian to participate in the Contest within 7 calendar days; otherwise, they forfeit their right to the prize. In this case, the Organizer will repeat the drawing and contact the alternate Winner directly.
- 6.4. 6.4. A single Winner may win and claim only one Prize from the Contest. Winning multiple prizes/Prizes by a single Winner in the Contest is prohibited.
- 6.5. 6.5. Before awarding the prize, the Organizer reserves the right to ask the winner to prove that they are the person who won the prize. In disputed cases, the Organizer reserves the right to make a final decision regarding the awarding of the prize..
- 6.6. If the contest entry contains elements of a personal nature, such as personal documents, a likeness, or audio or audiovisual recordings, etc., by submitting the contest entry, the contestant grants the operator, free of charge and for a period of 3 years, consent to use such elements of a personal nature for the operator's marketing purposes.

7. Method of awarding the prize

- 7.1. The Winner and the Organizer will agree individually on the method and date of prize delivery.
- 7.2. The Winner may, upon agreement with the Organizer, transfer the prize to another person.



- 7.3. Winners must claim their prize by September 30, 2026. After this period expires, the Winner loses their claim to the prize.
- 7.4. The Organizer is not liable to Contestants for any damages resulting from the provision of incorrect, incomplete, or outdated information by the Contestant, or from the Winner's failure to claim the prize. The Organizer shall not reimburse Contestants for any costs incurred in connection with their participation in the Contest or with winning the Contest.
- 7.5. It is not possible to file a complaint regarding any defects or errors in the prize.

8. Final provisions

- 8.1. By participating in the Contest, the Contestant agrees to the terms and conditions of the Contest and agrees to fully comply with them. By entering the Competition, the Contestant acknowledges that his/her personal data will be used by the Organizer for the purpose of conducting and evaluating the Competition. At the same time, by participating in the Contest, the Contestant agrees and confirms his/her cooperation with the fact that, in the event that he/she becomes a Winner in the Contest, his/her likeness will be recorded and used free of charge by the Organizer for the promotion of the Contest and the Prize in the Contest. The Privacy Policy is subject to a separate document published on the Organizer's website www.villasandyresort.com
- 8.2 Each Contestant acknowledges that he/she has been informed that Facebook and Instagram have no obligations to the Contestant and no such obligations are incurred by Facebook and Instagram as a result of participating in the Contest. The Contest Organizer represents that the Contest is in no way sponsored, endorsed, administered by, or otherwise associated with Facebook/Instagram and is not otherwise affiliated with Facebook/Instagram.
- 8.3 The Competition Organizer is not liable in any form for any direct or indirect damages arising from participation in the Competition. In addition, the Promoter is not liable for any technical malfunction, in particular network, electronics or computer failure.
- 8.4. The Organizer reserves the right to change the terms and conditions of the Competition. The Organizer's decision is final. If any provisions of these Competition Rules are invalid or become invalid, the validity of the remaining provisions of the Competition Rules shall remain unaffected. The Competition Rules are governed by the applicable law of the Slovak Republic.
